

## Offshore Wind Generation Practice

Offshore wind energy is a source of clean, non-polluting, electricity and is showing promise as a reliable source of renewable energy. - the negotiation and trading of RECs.

These attorneys have assisted clients with engineering, procurement, and construction contracts; operation and maintenance agreements; land acquisition and site leasing; local, state, and federal permitting and environmental compliance; and advice on the applicability of the coastwise laws to foreign vessels assisting in offshore wind farm development.

Our attorneys have significant involvement with the key agencies that affect offshore and onshore wind energy decisions, including: the Bureau of Ocean Energy Management ("BOEM") and the Bureau of Safety and Environmental Enforcement ("BSEE") of the U.S. Department of the Interior; the U.S. Department of Energy; the U.S. Coast Guard; the National Oceanic and Atmospheric Association; the Fish and Wildlife Service; the Federal Energy Regulatory Commission; and the North American Electric Reliability Corporation. We also have extensive experience with the National Environmental Protection Act and environmental assessments of wind energy projects, as well as familiarity with the stakeholder engagement process that BOEM uses for lease sales for offshore wind.

These attorneys have extensive experience in negotiating and drafting agreements for the sale of RECs, advice with respect to participation in and compliance with RPS programs, and advocacy before federal and state agencies with respect to the creation and implementation of both REC and RPS programs. Our representative offshore wind energy engagements include:

- ongoing work for a substantial offshore wind farm project to provide assistance in various contracts, including crew transfer agreements, the transportation and installation of foundations, port lease and stevedore agreements, turbine supply and installation agreements, and feeder barge agreements;
- the provision of regulatory compliance advice to an offshore turbine installation company in areas such as the coastwise laws (the Jones Act), Longshore and Harbor Workers Compensation, Occupational Safety and Health Administration jurisdiction, Coast Guard regulatory compliance, including vessel examinations and inspection, crewing requirements and citizenship, and visa issues;
- advice and obtaining rulings on the coastwise laws with regard to the use of U.S.-flag and foreign-flag vessels to assist in the installation, operation, and maintenance of offshore wind farms;
- advice to foreign construction specialists in negotiations to provide installation services in connection with an offshore wind farm project.
